

MINUTES OF THE MEETING OF THE BOARD OF TRUSTEES LINCOLNSHIRE-RIVERWOODS FIRE PROTECTION DISTRICT July 22nd, 2024

HELD AT 671 WOODLAND PARKWAY, VERNON HILLS, VERNON TOWNSHIP, LAKE COUNTY ILLNOIS

Trustee Wendy Meister called the July 22nd, 2024, Meeting of the Board of Trustees of the Lincolnshire-Riverwoods Fire Protection District to order at 9:02 a.m. with the Pledge of Allegiance at the Station 53 (671 Woodlands Parkway) Training Room.

Roll call attendance was taken as follows: Trustee Chris Kennedy–electronically; Trustee Julia Hamilton – present; Trustee Wendy Meister-present.

Also, in attendance were Chief Tom Krueger, Deputy Chief Eric Levernier, Deputy Chief Mike Brown, James Howard - Governmental Accounting; IT Coordinator/Project Manager Keith Halfman, Attorney Shawn Flaherty, Attorney Kelli Melin, members of the LRFD, LRFD Lt Steve Shetsky, AFFI Representative Art Thompson, Joel Babbit-NPPFA Benefits. Quorum present.

A motion was made by Trustee Meister to temporary make Trustee Hamilton, President "pro tempore" due to Trustee Kennedy attending electronically and needed for signatures. A roll call vote was taken as follows:

Motion carried.

Public comment – IT Coordinator/Project Manager Keith Halfman introduced several interns that will be assisting the District with various social media projects for the summer.

MINUTES: A motion was made by Trustee Meister to approve the June 19th, 2024, regular and closed meeting minutes as written, seconded by Trustee Hamilton. A roll call vote was taken as follows: Trustee Kennedy—yes; Trustee Hamilton—yes: Trustee Meister-yes

TREASURER'S REPORT: James Howard-Governmental Accounting reviewed the July 2024 Treasurer's report with the Board. A motion was made by Trustee Meister to accept the Treasurer's report as presented, seconded by Trustee Hamilton. A roll call vote was taken as follows:

ATTORNEY REPORT: Attorney Flaherty updated the Board in regard to several legislative bills.

FIRE CHIEF'S REPORT: Chief Tom Krueger updated the Board on:

- **1.** Chief Krueger updated the Board on the positive progression of our current Candidates.
- 2. Chief Krueger updated the Board of the recent structure fire on July 5th.
- **3.** Chief Krueger stated that the new hire oral interviews will take place on July 23rd-25th. A total of 21 candidates will be interviewed with the intention of hiring four (4) as soon as final eligibility list is complete.
- **4.** Chief Krueger notified the Board that the District will take ownership of the new ambulance on July 26th with an anticipated in-service date of early October 2024.

5. Joel Babbit-NPPFA Benefits introduced himself and provided the Board with information about the NPPFA and the services they can provide to the District.
